Suffolk Community Foundation was founded in 2005 to respond to local needs and has since become the largest independent grant-maker in the county. In 2024/25, through the support of our donors and partners, we awarded £3.8 million in grants to charities and voluntary organisations across Suffolk.

# **About the Sizewell C Community Fund**

Suffolk Community Foundation administers the £23m Sizewell C Community Fund for the 10-year construction period. This is a considerable fund which is being directed into East Suffolk, with a particular focus on communities most impacted by the Sizewell C development within the administrative boundary of East Suffolk Council

The Fund will be used to boost environmental, social and economic wellbeing and the Foundation will use its expertise to make sure that this funding brings the greatest benefits to our most impacted communities. This will include awarding grants to initiatives which are designed to minimise and offset the impact of the construction work.

This is an important opportunity for Suffolk Community Foundation and for local people. It comes at a time when rising demand and reductions in central funding are placing charities and community groups under ever-increasing pressure and, therefore, has the potential to be transformational for communities across the region, enabling a real and lasting difference. ### The Role of the Sizewell C Community Fund Grants Officer

Reporting into the Sizewell C Community Fund Project Manager, the Sizewell C Community Fund Grants Officer will work as part of the Foundation's grants team which ensures the effective and efficient delivery of the Foundation's grant-making through established funding programmes.

You will work specifically to oversee the management of grants within the overall programme. You will be the primary contact to advise, and support applicant organisations, support the distribution of the Fund to voluntary and community organisations across East Suffolk and monitor the use and impact of the grant awards.

You will proactively work in the heart of local communities, understanding what provision and resources are available, building relationships and exploring potential new ideas for grant funding opportunities, including project delivery and capital projects.

You will deal with fund enquiries, undertake application assessments and due diligence checks ensuring that supporting documentation is provided and compliant, and prepare panel papers.

You will also contribute to capturing the impact of the Sizewell C Community Fund, visiting funded projects to monitor progress of their projects, supporting where necessary and capturing feedback.

This is an important role within our team, ensuring that Sizewell C Community Funding reaches East Suffolk communities and organisations supporting those most impacted by Sizewell C.



## **Key Duties:**

- Build relationships with organisations and communities in the local Voluntary, Community, Faith and Social Enterprise (VCFSE) sector in East Suffolk to connect them into the opportunities of the Sizewell C Community Fund.
- Work with organisations to help strengthen their applications and understanding of applying for the Sizewell C Community Fund and connect them into other relevant funds and organisations where applicable.
- Offer and provide support and guidance on grant making policies and procedures to applicant organisations.
- Provide community outreach support to grant applicants, including organising and participating in one-to-one meetings, site visits, seminars and workshops.
- Process grant applications, determine their eligibility against guidelines, carry out due diligence checks and evaluate suitability for the fund.
- Prepare comprehensive grant assessment panel documents and collaborate closely with the Award Panel to ensure they are well informed in local challenges, equipped with essential information for making funding decisions, and guided in understanding our Grantmaking Policy.
- Follow robust financial control procedures in the payment of grants awarded.
- Maintain the grants management database ensuring that it is up to date and that effective data management is in line with current legislation.
- Attend events, meetings and presentations, some of which may fall outside of regular office hours, as required.
- Accept other responsibilities and activities that may present themselves, subject to additional duties and responsibilities falling within the experience and remit of the post.

- Energetic, positive and enthusiastic, a good team player.
- A good understanding of and unequivocal commitment to safeguarding and equality, diversity and inclusion (EDI).
